Benefits News

There has been a delay in providing information regarding the next two series of benefits events scheduled to be run before the end of March.

Introduction to National Non-Domestic Rates

The event begins with an introduction that puts NNDR in context. The current rates retention scheme is explained, giving delegates a greater understanding of why NNDR have become so important to local authority finances since 2013.

The following areas are then covered, ensuring delegates have a fundamental understanding of the key areas of business rates legislation and administration:

- how NNDR are calculated
- liability rateable occupation
- valuation
- completion notices
- relief and exemptions
- billing, collection and enforcement
