LGPS & Shadow Board Current Issues – Counsel opinion on ultimate responsibility & IORP

- Employing authority contributions / statutory debt
- Administering authority / no obligation to pay otherwise than out of fund assets
- Administering authority / not entitled to treat funds as their money
- Central government / not in any direct way guarantor of benefits
- Nothing in legislation gives LGPS payment priority (lender of money has priority)
- IORP applies / Article 8 / Article 18 suggestions to ensure full compliance
