#### **Purpose**

This event, being delivered by two half-day webinars, provides an essential introduction to the role of the audit committees that support police and crime commissioners and chief constables in England and Wales. The webinars are intended for members and staff who are new to audit committee working. They introduce the main areas of responsibility for an audit committee and help you to make a more effective contribution. In particular, they focus on enabling you to provide a useful check and challenge to staff reporting to you.

- The purpose of a police joint audit committee and how it is held accountable
- The governance arrangements of local policing bodies and their relationships to the audit committee
- The key roles and responsibilities an audit committee fulfils
- How an audit committee can be chaired effectively and the importance of good support for its effective working
- How to work with your internal and external auditors, including understanding audit reports
- Approaches to guestioning, challenging and supporting staff and auditors.

#### **Who Will Benefit**

The webinars are designed for recently appointed audit committee members for police and crime commissioners and chief constables. They will also benefit audit committee members who wish to challenge themselves to improve and identify new ideas. Officers who support audit committees will find them a useful opportunity to gain an unfettered view of what committee members really expect of them.
