## **CIPFA and CIMA open new doors**

Back in November we told you of a new partnership with the Chartered Institute of Management Accountants (CIMA), giving CIPFA members' rapid access to CIMA membership and the management accounting designation.

The CPFA to CGMA Top Up launched in December and is proving popular with CIPFA members that want to enhance their management accounting expertise while adding another globally-recognised accountancy qualification and designation to their professional recognition.

CIPFA chief executive Rob Whiteman and Andrew Harding, CIMA chief executive, management accounting, at the Association of International Certified Professional Accountants, which represents members of CIMA and the American Institute of CPAs (AICPA), gave an interview to Public Finance last month in which both of them explained the rationale for the collaboration.

Rob told Public Finance that the institutes were "more alike than we are different" but also highlighted that they offered different specialist accounting qualifications and suggested that public sector accountants were interested in using a wider range of techniques, such as the financial modelling common in management accounting.

"People in public bodies are often appraising company performance, for example, in relation to contract management, but also people are switching sector more," he said. "Both institutes recognise that."

Andrew Harding reinforced the 'very natural' collaboration and said the institutes had a long relationship built on trust and respect. "Our institutes have both worked in the public sector for a number of years, each bringing different things to it," he told Public Finance. "We've seen the government looking for what might be described as business-style financial skills to be brought in. The biggest driver for this is the way in which the world of work is changing, the rapidity of change and the need for all of us to be giving our members opportunities to maintain relevant skills."

The partnership follows that set up by CIPFA and the ICAS last year, built on a joint CIPFA-ICAS qualification for auditors and a joint CIPFA/ICAS membership opportunity for CIPFA members (see page 12 for further details). Rob told Public Finance he hoped collaboration rather than competition between institutes would increase and that CIPFA was trying to 'open doors' for members, adding: "If we're serving members well and they're able to do a better job, then we think it's in the public interest too".

## IR35: off payroll working in the public sector

Really great to see some excellent preparatory work from Penna on scoping and interpreting how the latest changes to IR35 will affect public services and their relationship with the interim staff market (paid typically to a personal service company ((PSC).

CIPFA is delighted to be one of many voices in Penna's current advisory board, which is tasked with helping to clarify what, to many, remains a very subjective assessment framework – due to come into force from 6 April.

Caught or exempt by the IR35 HMRC toolkit? This is the key question for thousands of interim staff currently and their public service paymasters, with the most common answer at the moment probably being "could go either way – depending on who you ask and their interpretation of the questions themselves".

But make no mistake. This is set to be a big deal for the sector and could add significant costs to an organisation who concludes that its interims are caught by the 'off payroll' status, where previously the PSC's own self-assessment may have kept them outside of its reach; especially if charge out rates subsequently increase to mitigate the reduced 'net' day rate payment that an employer will typically land on – having deducted and paid the tax & NI element straight to HMRC at source. However you slice it and whoever is ultimately responsible for calculating and paying over an interim's tax and NI contributions, the government is convinced that this switch in emphasis to make the employer or employing agency liable for these payments is set to cover more people and bring in more revenue to the Treasury. By extension, this will mean that somebody somewhere will be paying more within an already stretched sector.

It's still too early to model how this will all play out. How many people will IR35 now affect? What will this do to daily charge out rates quoted to public sector employers? What will the new administrative burden of complying with these new regulations look like for an employer and will these changes make the public sector less attractive to PSCs in favour of the private sector (which doesn't have these equivalent requirements)? All tough questions just now.

Certainly the potential impact on the interim talent pool for councils could be significant from IR35. If roles are considered inside its catchment or client employers apply it to all interim roles regardless, then it may reduce the financial viability for interims to take on assignments and therefore could shrink the pool of potential interims. For positions like chief accountants, Section 151 officers and finance business partners within social care, this is already small enough. If it were to get smaller then it may in turn restrict an authority placement client's ability to hire the resources needed and push up daily charge out rates to the sector, something that it can ill afford in the current financial climate.

Penna's work (and that of its advisory board) is committed to help find answers to some of these questions to help manage and mitigate, starting with more detail and advice to the sector on how best to prepare for IR35 operationally. CIPFA welcomes any such initiatives that will ultimately bring greater clarity and transparency to a very complicated area of employment.

Our 'call to arms' at the moment, then, would be for you to make sure that you or your employing organisation fully understand the implications of IR35 and to seek suitable advice and counsel about these impending changes, where you feel you do not. Because ignorance will be no excuse to HMRC post 6 April 2017 and this could easily become something that proves very costly if you either get the baseline assessments wrong for interim staff (your new organisational liability) - or simply assume that everybody is automatically caught by IR35 (and the employment market subsequently punishes you with higher day rates across the board).

Final legislation on IR35 will not be confirmed until late March 2017, which will leave a very short period of time to get everybody ready.



#### CIPFA CEO Rob Whiteman on Brexit White Paper

Rob Whiteman, CEO of CIPFA, commented on the government's White Paper *The United Kingdom's Exit from and New Partnership with the European Union*: "The government has clarified its position at high level, and so its next and more difficult challenge is to translate these objectives into proposals that are analysed, modelled and delivered.

"Sadly the UK will not achieve everything it desires, and so the government needs capacity to understand the trade-offs in terms of their societal and fiscal impacts. For public services reliant on EU workers, the most pressing issue is to understand the likely end point and develop plans to achieve service continuity."

#### Good advice on anti-bribery activity

The first chair of the Committee on Standards in Public Life, Lord Nolan, was clear: if in doubt, don't do it. This is good advice but organisations need more than good advice in place to prevent bribery.

In late 2016, a new anti-bribery management standard was introduced which sets out a new standard to help address growing concerns over bribery and corruption.

However, with the increasing reduction in financial and staff resources all public sector organisations will have to ask themselves whether the implementation is appropriate to the risk posed.

The development of a business case which considers the financial, political and reputational risk in a transparent way is a good place to start and a number of organisations have already gone down this route.

#### CIPFA comments on NAO's report on the Better Care Fund

The NAO has just produced a report on the Better Care Fund (BCF). The report states that "although innovative the preparation and planning did not match the scale of the ambition".

Jane Payling, Head of Health and Integration, observed that although service integration is an obvious choice for patients, families and NHS teams, it was always going to be "unlikely to achieve its desired first year outcomes due to the ambitious targets built in, combined with overall budget reductions."

The new report has given promising advice that will encourage the government to give the BCF more realistic expectations.

Jane said, "CIPFA fears that the same mistakes could be being made with NHS's Sustainability and Transformation Plans (STPs) as proposals may be over-optimistic and unachievable. It is critical then to revisit the deliverability of STPs before they unravel."

#### CIPFA comments on government's housing White Paper

Sean Nolan, Director of Local Government, stated about this development, "The move away from the long held policy of exclusively promoting home ownership is welcome." Sean was keen to comment that diversifying the market is fundamental to a healthy future market.

Sean stressed the crucial role that housing associations and councils still have to play but it is important to clarify that they must be allowed a greater capacity to build new homes and replace existing reserves, which were reduced under 'right to buy'.

Sean stated, "It is encouraging that the White Paper gives credit to the innovative ways local authorities are working to build new homes and also that the government will look at 'all the options' with them for increasing supply."

Sean added that it was reassuring that the shorter term initiatives that have been proposed are around the use of 'completion notices' which would place pressure on developers, effectively making them start building within the next two years from grant of planning permission. Furthermore, the support for brownfield sites, at planning stages, and an increase of advocating for smaller development sites, would mean that a more diverse range of builders would be employed to take on these projects.

CIPFA and three national housing organisations, ARCH, CIH, and the NFA have identified a set of high-level housing policy requests that would allow local authorities to invest in building more new homes and support the government in its delivery of their objective of one million new homes by 2020.

The proposal shows that with changes to specific areas of housing policy the sector has the potential to substantially raise its output without extra government grant.

The main high level policy areas in which changes are proposed are:

- flexibilities in borrowing caps
- greater stability and certainty of rental income
- better use of receipts following right to buy.

CIPFA will offer affiliate membership for all ICAI members with a fast track approach to full CIPFA membership.

#### CIPFA Police and Fire Conference: Implementing Police and Fire Integration: Finance and Governance Issues

The event started off with an introduction from Chair of CIPFA's Police and Fire Panel, Nigel Hiller, who was pleased to see a more integrated mix of both police and fire delegates. Nigel made it clear that "austerity isn't going anywhere" and that the response to this is to plan better by ensuring good governance and financial management.

The Policing and Crime Act 2017 having received royal assent on 31 January 2017, conference delegates were keen to discuss how this would start to affect them.

First up was Home Office representatives Kayleigh Chapman and Sarah Jones, who gave a very informative presentation, discussing 'Emergency services collaboration – implementation of the Policing and Crime Act 2017', which provided an update on implementation of the Act.

Audit Manager for Local Audit Code and Guidance for the NAO, Andrew Kendrick, brought forward 'Audit considerations for police and fire integration'. Andrew explained that these were early thoughts about what might happen around the oncoming change.

Phil Hayes impressed upon delegates that the LGA peer review still has a place, but needs to be incorporated under the new system. His presentation, 'An inspector calls: a new regime for the fire and rescue service' considered the new inspection regime, what the options were and the next steps in such a process. He touted the importance of 'showing your working' so that you are able to explain the reasoning behind decisions.

'Blue light collaboration within the wider picture' was given by CIPFA's

Director of Local Government and Police, Sean Nolan. Sean briefly discussed Brexit's impacts, the Policing and Crime Act (more importantly about what it doesn't discuss), and his personal view on the differences between the single employer and governance models. Most importantly he discussed the complexity of police and fire integration, using the analogy of floors on a skyscraper, which was then used throughout the rest of the conference. He also mentioned the importance of transparency, so that there is no temptation to 'take from Peter to pay Paul'.

Charles Garbett, Treasurer for the PCC for Essex and Chair of the Police and Fire Finance Technical Working Group, discussed the progress made so far, in preparing a business case, as Essex was one of the early adopters of the scheme.

After lunch Charles Kerr, Director of Finance and Corporate Services at Kent and Medway FRA, gave a particularly interesting presentation, in which he compared the current state of affairs to a football match, referring to his 'match rules'. Additionally he was able to give an insight from the fire viewpoint in comparison to Charles Garbett.

Dorothy Gregson, Chief Executive and Clerk for the PCC of Cambridgeshire, provided their view of being another early adopter of the new proposals, 'Cambridgeshire OPCC: view from an early adopter'. She emphasised the importance of a PCC having detailed and significant understanding of issues of the area if they are going to have a positive and effective impact during their tenure.

As an addition to the schedule, Chris Brain from CIPFA Property gave a talk on 'Collaboration: Getting the best

out of your estate', which impressed upon the audience the importance of knowing what your assets are worth, in short that data was king. He discussed with the audience the inherent problems of leaving a building, as communities see specific buildings as a representative of that service, which invoke an emotional response.

To finish, the NAO was represented by Louise Bladen, Director of National Audit Office. Bladen gave a presentation entitled 'The NAO's work on the Emergency Services Network' which discussed the incoming replacement of Airwave which is the current communications system, and the intrinsic risks in such a big project.

Nigel Hiller brought the day to a close, thanking the speakers, and event organiser, Alison Dewhirst.

Both Ian and Gillian also presented at the SAFA conference on 'digitalization supporting economic growth' and 'managing conflicts of interest'. Helping to put CIPFA firmly on the map, Gillian also sneaked in a handshake with the President of Bangladesh, Abdul Hamid.

#### Supreme Audit Institution of the Republic of Kazakhstan (SAI-KZ) – CIPFA DIP IPSAS and CIPFA Public Auditor Certification: As delivered by CIPFA & EY Kazakhstan with assistance from Asian Development Bank (Astana, Kazakhstan)

Representatives of the Accounts Committee for Control over Execution of the Republican Budget of the Republic of Kazakhstan and revision commissions of regions and Astana city obtained CIPFA's Certificate in Public Audit (International) in Astana, Kazakhstan.

The Accounts Committee for Control over Execution of the Republican Budget is the Supreme Audit Institution of the Republic of Kazakhstan. Revision commissions are regional external state audit agencies of the Republic of Kazakhstan.

Training was organised as a pilot project with assistance of the Asian Development Bank and featured the inclusion of CIPFA's Audit & Assurance (International) and CIPFA's Diploma IPSAS (DIP IPSAS) modules as delivered by CIPFA and EY's Academy of Business trainers respectively. This training is the first of its kind for the region, and featured the delivery, assessment and certification of content in the Russian language.

Training was arranged for the purposes of capacity building of external state audit agencies and for the professional development of public auditors in the field of accounting and financial reporting to include International Public Sector Accounting Standards (IPSAS) and auditing in accordance with INTOSAI international audit standards.

Following the training, 30 representatives from external state audit agencies of Kazakhstan gained international qualification CIPFA Public Auditor and in addition, received CIPFA's DIP IPSAS certification.

Commenting on the certification of SAI-KZ's 30 representatives, CIPFA's Brian Donnellan, Head of Global Development, said: "The CIPFA Public Auditor (International) certification programme is recognised in legislation as the highest category Public Auditor programme in Kazakhstan. On behalf of CIPFA, I wish to congratulate all 30 participants in SAI-KZ on their achievement and to thank EY's Academy of Business and SAI-KZ for excellent support throughout. The commitment and support from the Asian Development Bank, EY Kazakhstan and SAI-KZ paves the way for further capability building initiatives which is broadly welcomed."

The Chinese Government has signaled its ambition to move towards having accruals based accounts in the next five years. Kim Woods from CIPFA delivered a two-day training session in Manchester on the finer details of IPSAS in Mandarin.

Chinese officials followed these sessions with a visit to CIPFA's offices where they learnt from Richard Douglas, former DG for the Department of Health and Gillian Fawcett, Head of Governments Faculty about the trials and tribulations of implementing resource accounts in the UK.

This visit follows a number of interactions we have had with the Chinese Ministry of Finance. We will continue to support their exchange programme this year in any way we can.

In January, the NFIB released several new alerts. They covered phishing emails purporting to be from the Migrant Helpline, criminal networks targeting empty properties to obtain finance, overseas crime groups targeting UK based car leasing companies and non-existent animal welfare charities using social media to attract donations.

## Tools to help detect and deter bid-rigging

The CIPFA Counter Fraud Centre is working with the Competition and Markets Authority (CMA) to raise awareness of bid-rigging.

Bid-rigging is a form of cartel activity and is a particularly serious type of anti-competitive behaviour. It removes the incentive for companies to compete to win a contract, which in turn means purchasers do not receive true value for money.

Every year, local government alone spends around £60bn on procuring goods and services in the UK. Given this expenditure, it's worth remembering the signs of suspicious bidding patterns. They include:

- bids received at the same time
- different bids with identical prices
- bids containing similar or unusual wording, or less detail than expected
- likely bidders failing to submit a price
- bidders suddenly dropping out
- prices that seem much higher than underlying costs, or are higher than those in other bids although there are no logical reasons for cost differences
- prices that drop on the entry of a new or infrequent bidder
- the lowest bidder does not accept the contract or the successful bidder later subcontracts work to a supplier that submitted a higher bid
- last-minute changes, such as expected discounts disappearing
- a bidder knowing more about previous bids than expected.

#### 'CPFA to CA Top Up' – success for first CIPFA members

Congratulations are due to the first group of CIPFA members to have been awarded membership of ICAS, becoming joint members of CIPFA and ICAS.

The seven members succeeded in completing the 'CPFA to CA Top Up', through the ICAS Pathways route, which enables UK exam-qualified CIPFA members to gain the CA designation and ICAS membership, alongside their existing CIPFA designation and membership.

Each of the group elected to go through the ICAS Test of Relevant Expertise (TRE) Pathways route, which is open to UK exam-qualified CIPFA members with seven or more years' post qualification experience.

CIPFA member James Wallace, head of social security finance with the Scottish Government, was one of the first to take the TRE route.

He says: 'As with CIPFA, the global recognition ICAS has is clearly a benefit to any CV, and the access gained upon completion to ICAS services, including the technical guidance, is another clear benefit and one which I believed would be very complementary to my existing access to CIPFA technical services.

'I also viewed the TRE assessment as an independent verification that the experiences I have had in the public sector were appropriate and relevant to my continued growth as a professional accountant.'

Sitting alongside the TRE route into ICAS membership for members with seven plus years of post-qualification experience is the TPC – or Test of Practical Competence – another route enabling those CIPFA members with less than seven years' postqualification experience to become a CA through a combination of classbased learning and relevant work experience. CIPFA's other recent ICASgraduating members are Jaspreet Aujla, Alan Bennett, Ian Doig, Andrew Holman, Philip Jones and Ian Howse.

The group joining ICAS come from professional practice, the social housing sector and banking. Jaspreet Aujla, Head of Finance with Birmingham-based Housing & Care 21, says: 'I felt that membership would generally add 'strings to my bow'. As a specific example, the accounting and financial reporting requirements within housing are much more aligned to company accounts than those of the rest of the public sector, so I felt that membership of a body such as ICAS, alongside my existing CIPFA membership, would be really beneficial to me now and in the future.'

For CIPFA members thinking of taking up the joint membership opportunity, two of the candidates offer some words of support. James Wallace advises CIPFA members going through the TRE route to, 'start early, as it will probably take longer to complete your essays than you expect.'

'Also' he says, 'candidates should enlist their sponsors to help ensure that they are detailing their experiences at the correct level.' Jaspreet says the key to success in the TRE assessment is 'to focus on the reflection and learning, and to try to avoid just describing what happened.'

#### **Succession Planning**

Local authorities today face many challenges and a lack of financing is making it increasingly difficult to deliver crucial services. There is however a much overlooked issue which many authorities are failing to confront, like succession planning!

Identifying and developing the leaders of tomorrow is key to a local authority's sustainability and future performance while also making it easier to replace departing or retiring members of staff. Without forward planning there are several problems which arise and it is a factor that many chief executives say keeps them up at night.

In the short term, the departure of staff leaves a gap which may be temporarily filled by an interim staff member with a very fixed brief that deploys the required knowledge but these are commodities that take time to replenish within the organisation. This will only be amplified further with proposed changes to legislation around exit payments meaning the knowledge pool is further reduced and made harder to access.

In the long term, local authorities will need to engage in recruitment exercises which take time and energy that could otherwise have been devoted to training and developing the talent that already exists in the organisation. Succession planning increases organisational engagement, productivity and long term sustainability.

All told, the result is time and money are spent by authorities, in an age when both are in short supply. Succession planning isn't necessarily great news for recruitment consultancies, but it is a powerful and meaningful way for local authorities to shape their own future.

## Action under CIPFA's Disciplinary Scheme

The Institute's independent regulatory committees have taken the following actions in relation to Institute members/former members:

#### Mr Faysal Maruf

After a hearing held on 20 and 21 October and 1 and 7 November 2016, a disciplinary committee determined to issue Mr Faysal Maruf with a reprimand in relation to two matters.

The first involved Mr Maruf reducing or deleting PIA accruals at year end closedown without proper justification and the second related to Mr Maruf inappropriately authorising the movement of on-going revenue costs from one project into the capital accounts of another.

#### Mr Stephen Sutcliffe

After a hearing held on 14 and 15 November 2016, a disciplinary committee determined to issue Mr Stephen Sutcliffe with a reprimand in relation to his having breached the privacy and confidentiality of his ex-wife's private and personal email account by accessing it on three occasions and forwarding emails to his own account or to the account of his friend.

The forwarded emails concerned Mr Sutcliffe and his former wife's on-going matrimonial proceedings and included emails between his former wife and her solicitor in those proceedings.

#### Mervyn Bowley 1917–2016

Mervyn Bowley, who passed away in October after a long illness, had an outstanding career as both a CIPFA and ICA professional accountant.

Born in Kendal, Mervyn became a junior clerk with Kendal Borough Council Treasurer's Department in 1933 on a salary of £34 pa. Enthused by the accountancy work, he achieved second place nationally in the IMTA Intermediate exam. In 1938, he was promoted to assistant auditor at Oxford City Council and completed the first part of his finals.

Marriage in 1940 was followed by Second World War army service in North Africa, Sicily and Italy. Resuming his career in 1946, Mervyn completed his professional qualifications quickly. Rapid promotion followed; to Glamorgan (1948), Derbyshire (1951) and Cheshire (1959) where he was appointed deputy county treasurer, a position he served with distinction until 1979 when he retired. Away from the office, Mervyn made a major contribution to community life, actively serving the Parochial Church Councils. He also undertook a variety of treasurer roles, particularly his 18 year tenure as treasurer of the Multiple Sclerosis Society.

Mervyn served CIPFA with distinction for many years. He was a member of the CIPFA Council and was very active in CIPFA affairs both regionally and nationally. In Cheshire, on top of all the pressures that go with being part of top management, Mervyn performed his responsibility for training and staffing matters with humour and encouragement, always demonstrating the highest integrity, humility and kindness.

Mervyn was a gentleman and a master of his brief. He was an exceptional man professionally and also in terms of his humanity. He was patient, and supportive towards everyone he came into contact with. Mervyn was a giant of our profession and a champion of students everywhere. His retirement was local government's loss. His stature and achievements have long been acclaimed, but those who had the privilege of knowing him will, most of all, remember Mervyn with gratitude and real affection. *Alan Cope*.

#### **Public Finance Management – Global Advocacy**

Governance is all about representing people, managing resources, ensuring appropriate distribution of wealth, enabling opportunities and particularly prioritising the deployment of finance.

Public finance should involve transparency, accountability and ethical practices that extend to the benefit of the public. The point of advocacy is to prevent profiteering and exploitation in public activity.

Business today must consider the public consciousness and responsible delivery as businesses are viewed as partners in nation building rather than exploiters of resources at the cost of the public good.

Gone are the days that governments view 'tax and transfer' as a panacea for eradicating social disparity; the next step is constructive engagement of users, in governance of public advocacy. Hence the concept of public finance needs a reorientation to encompass responsibility and ensure transparent spending.

Frameworks are now in place so that misspending is accounted for and questioned. The inclusion of nongovernmental companies in such practices must be closely watched. The public, as well as the government, needs to be aware of not just what is spent but what is being bought; what public services are being delivered compared to the standards of quality and with what levels of efficiency. Many countries now hold equal opportunities enshrined into their constitutions, but this does not ensure that egalitarian values will be held up. Sometimes the reality is that millions are marginalised and are at the mercy of a few.

While public finance is vocal on how public bodies, including public enterprises, manage their funds, the understanding of what a public enterprise is has to change. Public enterprise is not limited to the traditional definition of a governmental controlling interest in the company but also those companies that engage in exploitation of resources to deliver goods and services that will impact the public good. Eventually a question will emerge, as to whether these companies can be said to be acting in the domain of public finance and for the public good.

From the above discussion it can be concluded that public finance needs a broader definition for global advocacy, considering the spectrum of challenges and the need to engage cohesively for a responsible government. To be a responsible government, governments needs to stretch beyond historical concepts like 'tax and transfer', to engage others to be part of nation building.

#### Montenegrin internal auditors and accountants awarded with international certificates

A graduation ceremony for the third generation of Montenegrin students enrolled into Training of Internal Auditors in the Public Sector (TIAPS) was held in Podgorica on 22 December 2016. Altogether 24 successful students were awarded with CIPFA certificates. Sixty-seven participants from all three generations of students were awarded with the on the job certificates.

The programme is financially supported by the German Government through Stability Pact Fund and by the Slovene Government through Slovenia's development co-operation, while the Ministry of Finance of Montenegro and CEF provided in-kind support. There are good prospects for continuation of the project and its localisation in the country.

The first generation of Montenegrin students that successfully concluded Public Accountants Certification Training (PACT) was awarded with international CIPFA certificates. Altogether 24 students received certificates. Nine tutors were engaged in the programme.

Unlike traditional data matching hubs, this is an endto-end service providing expert advice and operational support around sophisticated analytics. Staffed by qualified counter fraud specialists, CIPFA's overarching objectives for the service are to increase fraud and corruption detection, improve fraud prevention, share common risks across London, minimise losses and maximise recovery so that fraud and corruption do not pay.
