## Message from the President

S pring is definitely springing and at CIPFA that is certainly the case. It's hard to believe I am three quarters of the way through my presidential year and it is six months since our new chief executive Rob Whiteman joined us.

As I go round the regions and meet members, students, employers, partners and sponsors, I am continually amazed at how much is going on and how positive and upbeat everyone is. It is fantastic and uplifting - THANK YOU and keep it up.

You said, and we agreed, that a key priority is to strengthen CIPFA's voice. We have successfully brought on board three strong new players as strategic advisers. Ian Ball, immediate past CEO of the International Federation of Accountants (IFAC) is CIPFA's Chair of International leading our global engagement; Mike Farrar who recently stepped down as CEO of the NHS Federation joins us as Strategic Adviser, Health; and Stephen Hughes, a member well known to many as recent Chief Executive of Birmingham joins us as Strategic Adviser Local Government.

We've seen a continuing upward trend in student recruitment over the last twelve months as new starts on our public financial management qualifications doubled year on year, and with further UN agencies, as well as UNICEF joining the existing UNDP students, we are well on target to do the same again and more.

During the UK's national apprenticeship week it was great to be at the launch of CIPFA's innovative finance apprenticeship scheme. The scheme will be rolling out from the successful West Midlands pilot where members designed the scheme together with local employers. Apprentices gain an AAT Level 4 qualification.

In relation to the development of our professional qualification, we have now made our submission to the Financial Reporting Council to be the only 'Registered Qualifying Body' for local audit, providing training and registration services to members and firms providing public audit services following the abolition of the Audit Commission.

Finally, I was pleased to see the Commission make its press announcement that the 'national counter-fraud function will go to safe hands' ....CIPFA's! The function will transfer at the end of March 2015, to a new public sector 'Counter Fraud Centre' at CIPFA.

As we promised six months ago, CIPFA will be changing at pace and scale. Please keep contributing to the way forward and watch this space.

## Technical and policy round-up

## First authoritative study into financial reporting for NPOs

The Consultative Committee of Accountancy Bodies (CCAB) has published the first comprehensive international study into International Financial Reporting Standards for notfor-profit organisations (NPOs).

The study assessed the need and demand for stronger financial standards for NPOs internationally, and included a survey which received over 600 responses from 179 countries.

There appears to be support for an international standard with 72% of respondents agreeing it would be useful.

'This report clearly demonstrates that there is desire for some kind of international standard for the not-for-profit sector'

Ian Carruthers, Chair of the research steering group and CIPFA's Policy & Technical Director Responding to the findings, Ian Carruthers said:

'Strengthening transparency and accountability, while potentially reducing costs through consistency in reporting requirements would go a long way in supporting NPOs, donors and those they serve around the world.'

#### CIPFA/LASAAC consults on accounting for schools in local authorities

CIPFA/the Local Authority (Scotland) Accounts Advisory Committee (LASAAC) is running a consultation on *Accounting for Schools in Local Authorities in England and Wales* relating to the *Code of Practice on Local Authority Accounting in the United Kingdom 2014/15 (the Code)*, until 4 April 2014.

Accounting for Schools in Local Authorities in England and Wales was produced by the joint HM Treasury and CIPFA/LASAAC Public Sector Accounting for Schools Working Group.

The working group was set up after a CIPFA/LASAAC consultation in 2012, which suggested that voluntary

controlled, voluntary aided and foundation schools should no longer be consolidated into local authority accounts, and there were objections to this approach.

The working group has now concluded that voluntary controlled, voluntary aided and foundation schools should after all still be consolidated into local authority accounts, and the consultation seeks to find out whether consultees agree with this.

#### CIPFA consults on LGPS-specific supplement to the Role of the CFO in Local Government

CIPFA is inviting comments on a supplement to the *Role of the Chief Finance Officer (CFO) in Local Government* which explains the principles of the role of the CFO in the context of the financial administration of the Local Government Pension Scheme (LGPS).

This statement is addressed primarily to those CFO's holding the chief finance officer position in local authorities that are LGPS administering authorities.

However all local authority CFOs will have some interaction with the LGPS and should therefore possess the necessary technical knowledge and skills to engage with the administering authority as an 'intelligent client' of the fund.

## Get compliance right to maximise recovery

Across the country local authorities are preparing for the enforcement changes within the Taking Control of Goods Regulations 2013 that are being introduced on April 6.

The enforcement regulations are split into the following main stages:

- Compliance £75.00
- Enforcement £235.00
- Disposal of goods £110.00

At the moment local authorities are having conversations with their enforcement agents about what they expect them to provide for the £75 fee. It is vital that time is taken to get this stage right to maximise recovery and avoid:

- an additional £235 in fees being charged
- and facing complaints from debtors.

So here are a few questions to get you started:

- Do you want to have the same compliance procedure for every debt, or do you want to vary it on type or value?
- Do you want to review debts before they pass into enforcement for certain criteria?

How do you want the enforcement agent to treat those that constantly miss payments under their agreed arrangements?

Things on the list you hadn't considered? If so you might want to think about becoming a member of CIPFA revenues Consortium because as a group we have thought about these and many more issues, learning from others and picking up great ideas.

## Finance apprenticeship launch

During National Apprenticeship Week CIPFA launched a finance apprenticeship scheme, after the successful pilot in the West Midlands, last year.
